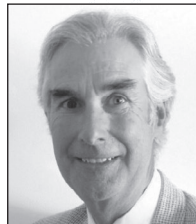

Michael N. Josselyn is a co-founder and former President of WRA. Mr. Josselyn formed the company to incorporate the best scientific information on the environment to assist clients with environmental compliance and to assure successful implementation of habitat protection and restoration actions. His work has focused on environmental permitting and habitat restoration, large scale conservation planning, and expert testimony. Mr. Josselyn has consulted internationally on wetland ecology and restoration. He has authored or edited several books and more than 50 articles on wetland ecology and mitigation published in national and international scientific journals. He was a Professor of Biology at San Francisco State University for 22 years and was the Director of the University's Romberg Tiburon Center for Environmental Studies. He was trained as a US aquanaut in the NOAA "Man-in-the Sea" program and participated in five underwater missions.

S. Keith Garner focuses on state and federal environmental laws, land use planning and entitlement procedures, and natural resources permitting issues for large residential, commercial and mixed use communities and energy generation and transmission projects, including wind and solar facilities. He provides legal and strategic planning advice to clients at every stage of the complex development process, including due diligence for land acquisition, project planning and permitting, regulatory compliance, and land use litigation. Mr. Garner handles a wide range of state and federal regulatory matters, including endangered species, wetlands, water quality and land use issues, initiatives and referendums, environmental review under the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA), Williamson Act contracts, and State Lands issues. He frequently manages the interdisciplinary teams needed to address the regulatory requirements and permit conditions.
